Privacy Policy.

This Privacy Policy applies to personal information collected through this website (saabparts.com) which is operated by Orio AB.

All references to "our", "us", "ourselves" or "we" in this Privacy Policy are deemed to refer to Orio AB, its subsidiaries, affiliates and associates.

- 1. Personal Information** Personal information is all information that can be used to identify an individual, for example name, address, phone number, e-mail address and personal preferences of that individual (referred to as "Personal Information" below).
- 2. Collection of Personal Information** When you visit our Website, we collect information such as your IP address and other web log information and statistics such as browser type and the pages you access on our Website. This information is not for the purpose to personally identify you. We also collect your Personal Information as referred to above, if you specifically register such information on our Website by for example filling out a questionnaire or if you contact us for any reason.

Depending on the services provided on our Website, you may be required to open an account on our Website in order to gain access to certain services or features provided.
